• Objectives of the training program :

The Master's degree in Industrial and Commercial Business Law is intended to train specialists in individual and corporate business law competent in the fields of commercial law (legal problems that can occur in the running of businesses and commercial transactions; craftsman, trader, EIRL status, etc.), company law, taxation, companies with notions of financial analysis and accounting. This training program includes the essential implications of European and international law on business law, as well as techniques to prevent difficulties and safeguard the company.

The legal aspects of IT (E-Contract Law and Internet of Things Law) are highlighted in order to prepare the future lawyer to get familiar with new technologies through law.

• Target audience

The training is primarily aimed at those with a degree in law. Registration in M2 is open to holders of :

- an M1 in law or an equivalent degree in economics or management for those who wish to further their knowledge or prepare a test involving legal subjects.
- another M2 in law, management or economics who wish to enhance their knowledge, prepare for a competitive examination or strengthen their skills.
- The course welcomes people who have prepared a diploma at a Business School as part of a dual course.
